Catherine: My most favorite thing about AA is meeting people that understand me, people who think outside of the box!

C: "One day at a time."

N: Do you have a favorite passage in the Big Book?

C: The Promises!

N: Is there something about your story that you feel passionate about telling?

C: I'm an open book for the young girls in rehab that I work with.

N: What is something in your story that you think is important to share to help people identify?

C: When a cop arrested me and I said, "Don't you know who I am?!" That is the audacity and ego of this alcoholic! (shakes head, laughs)

N: Besides your sponsor, is there anyone in particular who has been especially prominent in your recovery journey?

C: Elza, Sandy, Amanda, Lee, Jeanine.

N: Which principle means the most to you?

C: Willingness!

N: What was a challenge or fear when you first got into service?

C: Lack of confidence!

N: What is your favorite part of serving the AA community?

C: The people! Being around some good, hard working people that are passionate about the work they're doing for AA. And they don't have to be perfect, I love the people who make mistakes, we're here to share our true selves with each other!

N: What has been your favorite service position so far?

C: GSR, it helped so much with my confidence.

N: Do you have any goals for your current position?

C: Yes, to find someone to replace me! (laughs)

N: What has been helpful for you to balance your service commitments with life's other responsibilities?

C: I've learned to not compare myself to others and to only do what I'm personally capable of.

N: What do you have to say to the newcomer?

C: Smile! And welcome to our family.

N: What advice would you offer to someone new in service?C: Take your time on this one, make sure you can breathe in your sobriety before you take on more.



A Message from One of Our Members~

Trust in God and Clean House By Fred L

"Burn the idea into the consciousness of every man that he can get well regardless of anyone. The only condition is that he trust in God and clean house." Alcoholics Anonymous p. 98

As I write this, I've managed to string together 317 continuous days of sobriety, thanks to God, sponsorship and the fellowship of A.A. While many things have improved in that time, I still struggle with restlessness, irritability and discontent.

Life still happens. Situations beyond my control test me and throw stumbling blocks in my path.

But those words from p. 98 of the Big Book provide great comfort and motivate me to keep moving forward, putting one foot in front of the other, taking one right action at a time. I sometimes think of that quote as the "steps within the steps" because those two conditions – trusting my Higher Power and cleaning house – boil down much of the work detailed in the 12 steps into just six unforgettable words.

I struggle more with trusting in God than I do with cleaning house. I think that's largely due to the highly specific instructions contained in the 12 steps regarding how I can face up to my past and make right my previous mistakes. I continue to take a moral inventory and try to admit when I'm wrong. I keep an eye on my fears and resentments. I've learned to call my sponsor when faced with difficult situations when the right path isn't immediately clear. Those practices all help me to keep my side of the street clean.

But when people, places and things beyond my control don't go my way, when my only recourse is to trust that God's plan is perfect and that I'm right where I'm supposed to be, that's when my impulse to try to direct everything and everyone grows stronger. I find myself in such a situation right now as I type these words on my laptop.

So I pray.

I ask my Higher Power to relieve me of my anxiety. I ask only for knowledge of His will and the power to carry it out. I shut my eyes and breathe deep and focus on that point in my soul where God is still in the act of creating me. And I feel a little better.

I know enough about alcoholism to never say I'm cured of my disease. Some days, I wouldn't even describe myself as well. Yet I know that no matter what life throws my way, I can get through in relatively good shape if I just trust God and clean house.
